# 7:30 p.m. CONVENE SPECIAL CONCURRENT CITY COUNCIL/REDEVELOPMENT AGENCY MEETING

Mayor Abelson convened the Special Concurrent City Council/Redevelopment Agency meeting at 7:35 p.m.

1. PLEDGE OF ALLEGIANCE TO THE FLAG was led by Mayor Abelson.

#### 2. COUNCIL / STAFF COMMUNICATIONS

Councilmember Jones reported on his attendance at the March 10-12, 2010 California Redevelopment Association Annual Conference. There is a lawsuit against the State of California regarding the State's efforts to take redevelopment money away from cities, counties and special districts. The court has to issue a ruling within 90 days of March 3, however the Redevelopment Association is expecting a decision mid or late April because of the May 10 payment requirement. General consensus is that the decision is likely to be appealed. The California Redevelopment Association would like to get more local officials involved in getting the word out about redevelopment and with informing state representatives about what redevelopment money means for the betterment of the community in terms of business and employment. The Association is going to continue to support affordable housing, transit oriented development and will support and promote green building in redevelopment areas through building codes and standards. Councilmember Jones also reported that the Association reminded members of the 2014 compliance date for affordable housing.

<u>Councilmember Lyman</u> reported that the Crime Prevention Committee met last week and re-evaluated use of city resources and has postponed the March 22 Neighborhood Watch meeting until after the annual National Night Out event. The Bicycle Safety Rodeo has also been postponed and scaled down to accommodate city resources.

# A. Repeal and Re-enact El Cerrito Municipal Code Chapter 6.55 (Alarm Systems) and Include Fees for Alarm User Permits and False Alarm Fines

Conduct a public hearing and upon conclusion introduce by title, waive first reading and approve an ordinance repealing and re-enacting El Cerrito Municipal Code Chapter 6.55 (Burglar Alarm Systems) and adopt a resolution amending the City's Master Fee Schedule to include fees for alarm user permits and false alarm fines.

Mayor Abelson opened the public hearing.

<u>Speakers</u>: <u>Jon Sargent</u>, ADT Security Services, stated that false alarms have decreased nationally, stated that the proposed ordinance is based on a model ordinance and includes industry best practices. Mr. Sargent expressed his support for the proposed ordinance.

Tom Rood, President, East Bay Alarm Association, identified the major suppliers of alarm panels.

<u>Eugene Go</u>, El Cerrito, asked the city to study the alarm issue more and expressed a need for more education regarding the pros and cons of alarms and fees and the need for community communication, input and acceptance.

expiration. The Council also directed staff to send out a citywide mailer notifying all residents and businesses about the new alarm ordinance. Second reading scheduled for April 5, 2010.
