CONVENE SPECIAL CONCURRENT CITY COUNCIL/REDEVELOPMENT AGENCY MEETING

Mayor Potter convened the Special Concurrent City Council/Redevelopment Agency meeting at 7:34 p.m.

1. **PLEDGE OF ALLEGIANCE TO THE FLAG** was led by Mayor Pro Tem Abelson.
2. **COUNCIL / STAFF COMMUNICATIONS**

Redevelopment Agency Chair Jones reported that the Redevelopment Agency in closed session, on January 5, 2009, had discussed an update regarding the Target site and provided direction to staff. Additionally, on January 10, 2009, the City Council met with the West Contra Costa County Unified School District (WCCUSD) Board of Education with five other City Councils in open session. Councilmember Jones stated that although no action was taken, it was the hope of individual members that El Cerrito would be of some assistance to the School District in the future.

Councilmember Abelson reported on the weekend celebration of Martin Luther King, Jr.'s life which included a documentary on Martin Luther King, Jr. that was held at the Cerrito Theater on Sunday. The documentary was well attended and included many children. On Monday the annual parade and march culminated at the El Cerrito High School Gymnasium. This was the first community activity to take place in the new gym. A variety of groups performed including youth and senior groups. One senior group, the Senior Soul Steppers, included one member of the City's Committee on Aging.

Councilmember Lyman stated, regarding the January 5 WCCUSD Board of Education meeting, that the city's acquisition of the library/senior center site is one way that El Cerrito can provide a cash infusion to the school district to help them with their funding gap.

Councilmember Cheng announced that the Local Government Commission, a statewide non-profit, is sponsoring a monthly lecture series for all East Bay elected officials. The topic at the January 29, 2009 event is SB 375 and will feature several notable speakers. There will also be various monthly discussions about transit oriented development. Councilmember Cheng stated that given that CEQA guidelines are being reformed now and that there are hearings regarding what can be done about greenhouse gasses and what should be considered in environmental review there is a great opportunity for El Cerrito to stay ahead of the curve and mold its policies to work with greenhouse legislation and rules.

Mayor Potter acknowledged this inaugural day of celebration and extended her congratulations to President Obama and the entire country. Mayor Potter also noted that former El Cerrito Mayor Letitia Moore attended the inauguration at the U.S. Capitol and represented El Cerrito's spirit in the celebration.

3. ORAL COMMUNICATIONS FROM THE PUBLIC

Peter Loubal, El Cerrito, expressed his displeasure with El Cerrito redevelopment projects, particularly the money spent on redevelopment and what has been achieved.

Linda Moss, El Cerrito, representing Friends of Cerrito Theater, expressed the Friends support for the Cerrito Theater, particularly, for its role in the community, the creation of a mini-entertainment district, its role in attracting attention to El Cerrito, and the Theater's recognition

as an historically significant restored art deco era theater.

Peter Loubal, El Cerrito, commented on the Cerrito Theater and stated that it was not worth the large subsidy. Mr. Loubal criticized the initial Target deal and stated that the public should decide the best course of action for the theater.

Sewall Glinternick, El Cerrito, thanked the City Council and City Staff for their assistance over the past thirteen years and announced his retirement from the El Cerrito Chamber of Commerce at the end of the month. Mr. Glinternick announced that the new Chamber manager will be former Fire Chief, Mark Scott.

7. **POLICY MATTERS**

REDEVELOPMENT AGENCY ITEM

A. Negotiation with Target Corporation

Staff is requesting approval of a letter agreement with Target Corporation putting a stay on the Agency's repurchase rights from January 23, 2009 to April 30, 2009.

Presenter: Lori Treviño, Redevelopment and Economic Development Manager.

Speaker: Peter Loubal, El Cerrito, characterized the Target issue as a problem that was inherited by current staff and stated that the city has not dealt with the Del Norte problem very well.

Action: Moved, seconded (Potter/Abelson) to direct staff to prepare a letter agreement with Target Corporation to place a stay on the Agency's repurchase rights from January 23, 2009 to April 30, 2009.

8. COUNCIL ASSIGNMENTS/LIAISON REPORTS

- A. Mayor Potter announced that the Arts & Culture Commission's second gallery exhibition is being installed this week. Additionally, the West County Mayors Supervisors & Supervisors Association monthly meeting has been cancelled due to a conflict with the Annual League of California Cities Mayor and Councilmember Training in Sacramento.
- B. Mayor Pro Tem Abelson reported on her attendance at the East Bay Division of the League of California Cities on January 15. The featured speaker was Dan Hatfield, Editorial Page Editor for the Bay Area News Group. Mr. Hatfield stated that newspapers are in poor financial shape due to their inability to sell advertising. Mayor Pro Tem Abelson received a list of 2009 League Federal Priorities at the meeting. Senator DeSaunier also provided a brief update on the state budget. Mayor Pro Tem Abelson also reported that the Environmental Quality Committee Subcommittees reported on their efforts at the Committee's last meeting. Individual subcommittees include: 1) Incentives for Solar Energy Efficiency Retrofits; 2) Reduction of non-biodegradable packaging in El Cerrito; and 3) City Environmental Recognition Program. Mayor Pro Tem Abelson informed the public that she received an email from the Contra Costa County Transportation Authority about the Hilltop Bridge Replacement Project. On Saturday January 24 from 9:00 p.m. to January 25 11:00 a.m. I-80 is scheduled for a full highway closure for bridge demolition.
- C. Councilmember Cheng reported on the Design Review Board's January 7, 2009 consideration of design plans for the Stege Sanitary District. The Board approved the design plans with conditions. The Board also looked at the replacement of trees at Del Norte Place.
- D. Councilmember Jones – No report.
- E. Councilmember Lyman reported that the Crime Prevention Committee had met last week is planning a Bicycle Safety Day for 2009 which will focus on the demonstration of bicycling skills, bicycle maintenance and highlight the City's bicycle patrol officers. The event will be held on May 16, 2009 from 12:00 p.m. to 4:00 p.m. in the DMV parking lot. Additionally, the Crime Prevention Committee is sending out letters to all those business and property owners who have successfully complied with the 2007 Video Surveillance Act.


