## RESOLUTION 95-111

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO DECLARING CANVASS OF CONSOLIDATED ELECTION HELD ON NOVEMBER 7, 1995, AND ACCEPTING CERTIFICATE OF THE COUNTY CLERK OF THE STATEMENT OF THE RESULTS OF THE ELECTION.

WHEREAS, the City Council of the City of El Cerrito, by Resolution 95-60 adopted on June 19, 1995, duly called and ordered held in said City of El Cerrito a general municipal election on November 7, 1995, for the purpose of electing the following municipal officers of said City of El Cerrito:

Two (2) councilmembers for full terms of four (4) years; and

WHEREAS, pursuant to said Resolution 95-60, said general municipal election was held on Tuesday, November 7, 1995, in accordance with law, and the votes thereof received and canvassed and the return thereof ascertained, determined, and declared in all respects as required by the law, and the County Clerk of the County of Contra Costa has duly filed with the City Clerk a statement of results of said election;

NOW, THEREFORE, BE IT RESOLVED, determined and declared by the City Council of the City of El Cerrito as follows:

- 1. That the certificate of the County Clerk of result of the canvass of election returns, now on file with the City Clerk, be and the same is hereby approved and adopted and is hereby entered on the minutes of the City Council as a statement of the result of said elections.
- 2. That the whole number of votes cast in said City at said consolidated election was 5,502 votes.
- 3. That the list of candidates nominated for the office to be filled at said general municipal election and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk as required by law, and the number of votes cast in favor of each of the candidates were as follows:

4. That Norman Charles La Force and Jane A. Bartke received the highest number of votes given for said office of city councilmember and were thereby reelected councilmembers for the full term of four years.
