Valued in the City of El Cerrito transferred a Utility User Tax (UUT) of \$9 in 2007. EBMUD will collect the tax on behalf of the City of El Cerrito, with all revenues going to the city. This is the first time the tax has been levied on water bills so you will be retroactively billed the tax that applies to water related charges from July 1, 2008. These charges will be billed in six-month increments until EBMUD is able to include the tax on your water bill.

Your total bill of \$23.04 is for the period July 1, 2008 thru December 31, 2008 and includes El Cerrito UUT charges only, based on previously billed water-related charges:

A second bill will be sent to you in August for the period January 1, 2009 through June 30, 2009. A third bill will be sent in February 2010 for the period July 1, 2009 through December 31, 2009.

DO NOT include your UUT payment with your regular water bill payment. Until the charge is included on the EBMUD water bill, your payment will be processed separately from EBMUD water bill payment. Please use the enclosed envelope and mail your payment to EL CERRITO UUT, PO BOX 23460, OAKLAND, CA 94623-0460.
