NOTICE IS HEREBY GIVEN that the El Cerrito City Council will conduct a public hearing to consider adopting a resolution declaring that weeds, rubbish, litter, or other flammable material on certain real property constitutes a public nuisance; and adopting a resolution overriding objections by property owners and ordering the City Manager or his designee to abate certain public nuisances pursuant to El Cerrito Municipal Code Chapter 16.26.

NOTICE IS FURTHER GIVEN that said hearing will be held on Tuesday, July 21, 2020 at 7:00 p.m., or thereafter via teleconference.
