RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL CERRITO DECLARING CANVASS OF CONSOLIDATED ELECTION HELD ON NOVEMBER 6, 2001, AND ACCEPTING CERTIFICATE OF THE COUNTY CLERK OF THE STATEMENT OF THE RESULTS OF THE ELECTION.
